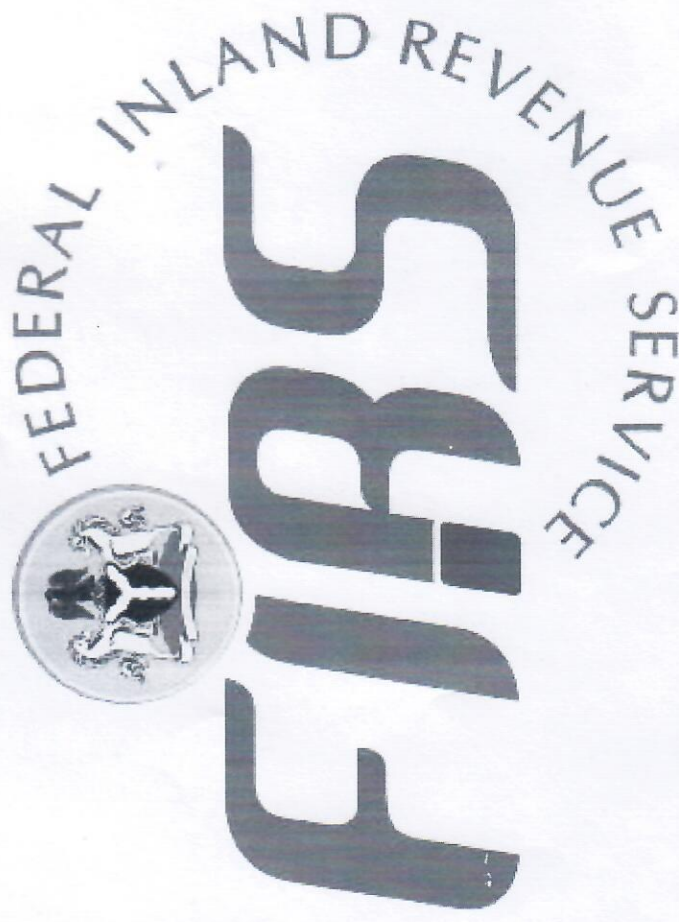

The Report on Taxes Collected by FIRS for the Month of March, 2023 to the FAAC Meeting Holding on 18th May, 2023.

1.0 INTRODUCTION

On behalf of the Executive Chairman of Federal Inland Revenue Service, I am delighted to present to the Federation Account Allocation Committee, details of the performances of the scheduled taxes of the Service for the month of April, 2023 as attached in Appendices I – IIIA, B & C, and summarized below:

1.0 PETROLEUM PROFIT TAX (PPT):

The PPT collection for the month of April, 2023 was ₦190.316 billion. This performance is lower than March 2023 collection of ₦368.784 billion by ₦178.468 billion representing 48.39% decrease. It is lower than the 2023 monthly target of ₦395.172 billion by ₦204.856 billion (i.e., 51.84% decrease).

The reason for the decrease in the PPT collections when compared with previous month is due to decrease in receipt of PSC.

2.0 COMPANIES INCOME TAX & OTHERS (CIT, WHT, CGT & STD)

The CIT & other taxes collection for April, 2023 amounted to **₦151.399billion**. When compared with the 2023 monthly target of **₦209.373 billion**, it shows a negative variance of **₦57.974 billion** or **27.69% shortfall**. This represents a performance level of **72.31%** to the target. It is lower than the previous month's collection of **₦163.857billion** by **₦12.458billion** or **7.60%**. The decrease in performance is as a result of decrease in CIT & other taxes payments received for the month.

3.0 VALUE ADDED TAX (VAT)

The Total VAT collection for the month of April, 2023 amounted to **₦217.743billion**. When compared with the 2023 monthly target of **₦246.148billion** it translates into a performance level of **88.46%**. It is lower than the **₦218.786billion** collected last month by **₦1.043billion** or **0.48%**. The slight decrease in the collection for the month relative to the preceding month was due to slight decrease in the consumption of VAT-able goods.

4.0 ELECTRONIC MONEY TRANSFER LEVY (EMTL)

The collection for April 2023 amounted to **₦15.121billion** and this is reported in our collection for the month.

5.0 TOTAL COLLECTED INTO FEDERATION AND VAT POOL ACCOUNTS

The total amount collected for Federation, VAT and EMTL in April, 2023 is **₦574.579billion**. This performance is lower than the 2023 monthly target of **₦862.112 billion** by **₦287.533 billion** or **33.35%** and a performance level of **66.65%**. It is lower than the amount of **₦766.519billion** collected in March, 2023 by **₦191.940 billion** or **25.04%**.

When all the tax types above are compared to the total collection of **₦574.579 billion**; PPT collection of **₦190.316 billion** represents **33.12%**, CIT & other taxes collection of **₦151.399billion** represents **26.35%**, VAT collection of **₦217.743 billion** represents **37.90%** while EMTL collection of **₦15.121 billion** represents **2.63%**.

Note: The exchange rate used is the CBN mandated exchange rate of USD 434.0800, EURO 483.8316 and £549.4703.
